## RECENT CASE

- A successful appeal against a finding of liability based upon "res Ipsa Loquitur"
- Settlement of a claim for a series of heads of loss which were the 'fruits' of another claim (former husband) following his serious brain injury and the need to 'fund' two households.
- Achieving acceptance by a former police officer of a greatly reduced Part 36 offer, including consequential costs orders.
- Successful settlement on the eve of trial of a claim by a Prison Officer against the HO for injuries and reduced earnings.
- Settlement for senior MOD intelligence officer following road rage attack.
- Achieving compromise of liability with 40% Contributory negligence following raising of FD in respect of liability assertions in Particulars of Claim.
- £1m+ settlement in brachial plexus and chronic pain claim.
- Mediated settlement close to £1m for a Protected Party with complex Dissociative Disorder.
- Mediated settlement of £840,000 in a claim for a Protected Party, psychiatrically injured at 2 years, and suffering continued symptoms into early adulthood.
