---

Michael appears in hearings (and has acted in a number of reported or cited cases) in courts and tribunals across South West England and South Wales, as well as in London and further afield, including:

- Fast track and multi-track trials, a wide range of interim and other hearings, case and costs management conferences and appeals in the High Court (especially the Business and Property Courts, Chancery Division and Probate Registry) and the County Court; and
- Final and other hearings in the First-tier Tribunal, Property Chamber, Residential Property and Land Registration Divisions, LVT and RPT.

Further to this, Michael appeared in the Court of Appeal on the significant proprietary estoppel case of *Winter v Winter* in 2024.

He also represents clients in mediations, as well as conducting negotiations and conferences and undertaking advisory and drafting work in all of the areas mentioned here.

### **B v G Council (2025)**

Property Damage: 2-day liability trial in a claim concerning damage caused to a property, which incorporated a boathouse and use of a slipway, during flood prevention works carried out on the edge of a stretch of tidal water.

---

### **Shepherd v Jenkins [2025] UKFTT 00770 (PC)**

Boundary Dispute: 3-day trial of a boundary dispute, set in a settlement connected with the World Heritage Site of Avebury, based on documentary title and adverse possession.

---

### **Packer v Packer [2025] EWHC 27 (Ch), [2025] 1 WLUK 84, [2025] Costs LR 1, [2025] 11 CL 15**

Costs consequences of withdrawing pleaded allegations at a pre-trial review.

---

### **Winter & Winter v Winter & Anor [2024] EWCA Civ 699, [2024] 2 FLR 1065, [2024] WLR (D) 287, [2024] PLSCS 115, [2024] All ER (D) 94 (Jun), [2024] 6 WLUK 353, [2025] 1 CL 178, 27 ITELR 389**

Michael, led by Hugh Sims KC, appeared in the Court of Appeal on this significant proprietary estoppel case (which has since been cited in other cases and practitioner texts), acting for the successful respondents to the appeal (who were the successful claimants at first instance), where the Court drew together previous authorities to give guidance on the correct approach to assessing detriment, especially if a claimant suffers unquantifiable non-financial disadvantages but also receives significant financial countervailing benefits.

### **Winter & Winter v Winter & Anor [2023] EWHC 2393 (Ch), [2023] 9 WLUK 287, [2024] WTLR 327, [2024] 5 CL 220, [2023] All ER (D) 07 (Oct), Zacaroli J**

Winter v Winter at first instance in the High Court.

---

### **C & Ors v C & Ors (2023)**

Right of Way: 3-day trial as to the existence and extent of a right of way alleged to have arisen by prescription, where declaratory and injunctive relief and both aggravated and exemplary damages were claimed for alleged trespass.

---

### **Cain v Ash, Bowles & Roylance [2023] UKFTT 00492 (PC)**

Adverse Possession: 3-day trial of an application for adverse possession of land, made 2 years after the rejection of a previous application under Schedule 6 of the Land Registration Act 2002.

---

**Reed v Pearson, Pollard & Born [2022] EWHC 2292 (Ch)**

Overage: Claim for payment under an overage deed based on whether, inter alia, certain General Permitted Development Orders made under the Town and Country Planning Act 1990 amounted to a grant of 'Planning Permission' as defined by the deed so as to trigger such payment.

**Price v Saundry & Sanders [2019] EWHC 1039 (Ch) (reversed in part by Court of Appeal but not for Michael's client [2019] EWCA Civ 2261)**

Liability for costs of claim to remove trustees where claim not pursued to trial.

---

**Meldrum & Freeman v West (2019), HHJ Jarman QC (cited in argument in Court of Appeal in Jarvis v Evans [2021] 1 WLR 24)**

Effect of Housing (Wales) Act 2014 on tenancy possession claim by mortgage receivers.

---

**Pendra Loweth v North (2013-15) (Michael appeared in First-tier Tribunal and drafted appeal which succeeded in Upper Tribunal [2015] UKUT 91)**

Liability of tenants to pay service charges to management company under lease.

**Day v Shaw [2014] EWHC 36 (Ch), [2014] 2 P & CR D1, [2014] All ER (D) 120 (Jan), Morgan J**

Equity of exoneration and its effect on holder of charging order.
