PROPERTY & ESTATES

REAL PROPERTY

All aspects of the law of real property, including title, boundaries, adverse possession, easements, covenants, options and trusts of land. Ewan's analytical and advisory work has regularly been praised in Chambers UK (see below), and includes matters ranging from private client easement disputes to multi-million pound developments. Ewan's recent clients have included major renewable energy and railway companies, charities, developers and local residents' associations and action groups.

LANDLORD & TENANT

Ewan has an extensive LTA 1954 practice, including as clients some major national retailers. He regularly gives seminars on commercial landlord and tenant developments, on the 1954 Act and general issues such as break clauses and liability for repairs. He also deals with all aspects of residential landlord and tenant law, ranging from the last remaining Rent Act tenancies to long leasehold extensions and LVT claims.

WILLS, ESTATES & INHERITANCE

Ewan advises and acts on all aspects of the law of succession, including the validity and interpretation of wills, the duties of executors and administrators and claims for provision against estates, via the 1975 Act and estoppel. A trained mediator himself, he frequently advocates and represents clients in early mediations or negotiations of estate-based claims.

PROFESSIONAL NEGLIGENCE

Ewan advises and acts in professional negligence claims arising out all of the above areas, typically involving the mishandling of conveyancing, estates or property litigation. He has frequently advised clients on claims arising from lost or unsecured overage payments, loss of claims through limitation or adverse compromises, and failure to pursue clients' best points. His principal aim in such matters is to encourage early settlement through the use of clear and persuasive protocol letters and round table negotiation.
